**Eligible Applicants**

Applicants should be organizations classified by the IRS as 501(c)(3) nonprofits, churches, tax exempt schools or governmental entities, applying for money for initiatives or programs that specifically benefit the Leslie Community.

**Eligible Grants**

Grant money cannot be used for normal operating expenses or faith formation.

**Grantee Responsibilities**

In order to receive a grant, grantee must sign a letter of agreement. Any misuse of funds deemed by the board may result in repayment of these funds.

Grantee must provide an evaluation showing how money was spent, providing evidence such as photos or receipts. Grantee must provide a statement of outcomes realized from the grant.
