We have recently completed construction of our initial building a 4800 square feet greenhouse located at 835 Rice street. The company has provided pictures of the completed project along with our initial site plan as well as a modified site plan proposal depicting our plans for future expansion. The company wishes to construct two additional buildings as well as expand our current building. The second proposed building a 2000 square feet structure will act as an office and processing facility for our crops. The third building and expansion of our current building will allow us to have two 9600 square feet greenhouses allowing our Company to scale and remain competitive in the growing Michigan cannabis market. This will also allow the Company to offer more jobs and support to the community of Leslie Michigan.








